## ADMISSION CRITERIA & PROCEDURE

we are taking admissions fully based on 11 Multi Drugs Test and 3 Blood Tests which are given below, the blood tests are necessary, in case of any positive result of HIV, we are not extending the admission process further while the rest are treated additionally with rehabilitation. For admission purpose patient relatives like mother, father, brother, sister, daughter, son, uncle, wife etc. are only allowed to admit their patient with proper official documents requirements like NIC, Contact No and Address etc. For international drugs addicts' admissions, proper official documents are required otherwise the admission process will not be extended.

## STANDARD OPERATING PROCEDURE OF OUR RESPECTIVE REHAB CENTER FOR DRUG ADDICTS

Our operating procedure of our rehab center for drug addicts are:

- The initial stage is multi drugs and blood tests which are already mention above in the admission criteria section.
- The second stage is detoxification: 14 to 24 days are for detoxification depend on the individual age and drugs addiction duration. In detoxification proper medications are provided to the patients according to our consultant doctor.
- The third stage is Rehabilitation: 66 days are for rehabilitation services. In these 66 days services like
  - Group Sessions,
  - Individual Sessions,
  - Family Sessions,
  - Counselling,
  - Educational Group Sessions,
  - Different Therapies,
  - Sports Activities are provided.
  - In case of any psychiatric issues proper medications are provided according to our psychiatrist.
  - During detoxification some complications may occur which are given below, these complications and their treatments are part of the detoxification.

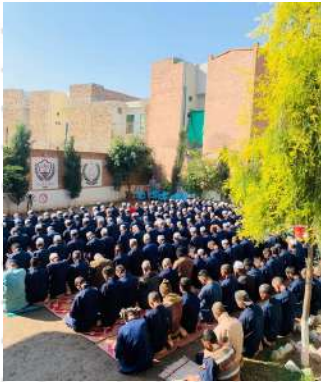
